Introduction

Overview of the Website and System

ADAMftd Ltd ("ADAMftd") operates a comprehensive platform designed to provide users with access to a wide array of data related to international trade, including company data, economic data, and trade transaction data. Our website and system facilitate in-depth analysis and insights into global trade dynamics, enabling users to conduct due diligence, market research, and compliance checks through a single interface.

Acceptance of Terms

By accessing and using the ADAMftd website and system, you agree to be bound by these Terms and Conditions of Use and all applicable laws and regulations. If you do not agree with any of these terms, you are prohibited from using or accessing this site. The terms "we", "us", "our", or "ADAMftd" refer to ADAMftd Ltd, and "you" or "your" refer to the user or viewer of our website.

User Account and Registration

Account Creation and Requirements

To fully access the features and services offered by ADAMftd, you must register for an account. During the registration process, you will be required to provide certain information, such as your name, email address, and company organization and, if applicable group affiliation, ownership, control persons, and create a password. You may also be asked to provide additional information.

User Responsibilities and Account Security

As a registered user, you are responsible for maintaining the confidentiality of your account and password and for restricting access to your computer, and you agree to accept responsibility for all activities that occur under your account or password. You must take all necessary steps to ensure that the password is kept confidential and secure and should inform us immediately if you have any reason to believe that your password has become known to anyone else, or if the password is being, or is likely to be, used in an unauthorized manner.

You are responsible for ensuring that the details you provide us with are correct and complete, and for informing us of any changes to the information you provided at the time of registration. We reserve the right to disable any user account at our sole discretion, should you have failed to comply with any of the provisions of these Terms and Conditions, including if any information you have provided is incorrect or incomplete.

Each account is personal and cannot be shared or used by more than one user. However, within your account, you may create multiple user profiles (if allowed by your subscription plan) to allow your colleagues within the same legal entity, but not an affiliated or associate entity, to access our services under your account umbrella.



Use of the Platform

Permitted Uses of ADAMftd Services

ADAMftd services are designed to support a wide range of business and compliance activities. Permitted uses include:

- AML Compliance: Using the platform to verify adherence to Anti-Money Laundering regulations.
- KYC Compliance: Conducting Know Your Customer checks to verify the identities of clients.
- Company Due Diligence: Investigating business entities to assess their legitimacy and operational history.
- Supply Chain Mapping: Visualizing and analyzing supply chain connections and dependencies.
- Supply Chain Due Diligence: Assessing risks associated with suppliers to ensure they meet compliance standards.
- Compliance with Laws Relating to International Trade: Ensuring adherence to international trade regulations and laws.
- Market Research: Gathering data to analyze market trends and consumer behavior.
- Economic Analysis: Conducting economic studies and forecasts based on available data.
- Tracking Shipments of Goods Internationally: Monitoring the movement of goods across borders to ensure compliance with customs regulations.
- Economic Modelling: Using data to build models that predict economic outcomes.

User Contributions

Types of Data Users Can Contribute

Users can enhance the platform by contributing various types of data, including, but not limited to:

- Images and Descriptions: Photos of business entities and descriptions of their operations.
- Entity Details: Updates or corrections to addresses, phone numbers, websites, and contact information of entities.
- Related Entities: Information on affiliations and connections between related entities.

Conditions for Contributing Data

However, contributors retain ownership of any original content they submit, subject to the licenses granted herein.

Permanency of Contributions Upon Account Cancellation

Contributions made to the platform remain in the ADAMftd database even after a user cancels their membership. This is to ensure the continuity and integrity of the data provided to all users. Data contributed by users will continue to be used in accordance with the terms of the license granted at the time of submission, unless explicitly requested for removal in application of applicable law, in respect of which the user bears the burden of proof.

Prohibited Activities and Restrictions

Users of the ADAMftd platform are prohibited from engaging in activities that could harm or damage other users, entities, or the platform itself or ADAMftd. This includes actions that are unlawful or that contravene the ethical use of the platform. Specifically, the following activities are prohibited:

Including for legal fees, shall be repaid to ADAMftd Ltd by the user.

The arbitration will be conducted under the rules of Singapore International Arbitration Centre, and the governing law of the Arbitration.



Modifications to Terms and Conditions

Notification of Changes to Terms

ADAMftd reserves the right, at its sole discretion, to modify or replace these Terms at any time. If a revision is material, we will provide at least 30 days' notice prior to any new terms taking effect. What constitutes a material change will be determined at our sole discretion.
